2. Incorporate a contractor's statement of release, as follows:

Contractor's Statement of Release

In consideration of the Modification agreed to herein as complete equitable adjustment for the Contractor's 19 August 2004 request for equitable adjustment for non-AOR usage of the San Diego Metropolitan Area Network during the period 01 October 2003 through 30 September 2004, the Contractor hereby releases the Government from any and all liability under this contract for further equitable adjustments for costs incurred directly for the percentage of the data transport across the San Diego Metropolitan Area Network used by the Government for the period of time 01 October 2003 through 30 September 2004. Nothing contained in this Modification shall be deemed to preclude Contractor from submitting a claim or request for adjustment for any costs or for any events (other than for the event specifically described above) or the costs incurred for such event after the time period specified herein.

b. A conformed copy of the revised contract is made a part of this modification as a result of the changes outlined herein.

c. All other terms and conditions of contract N00024-00-D-6000 remain unchanged and in full force and effect.
